DIRECTIONS FOR USE

DO NOT use on Crop Land or Pasture.

FIRE ANTS: Treatment can be made on lawns, cemeteries, golf courses, park areas and nurseries. Area Treatment—The entire area should be treated at the rate of 9 OZ. per 1000 square feet. Application can be made with a fertilizer distributor or seed sower. Wash thoroughly after application. The best time for treatment is from late fall to early spring. Do not apply to areas planted to food crops. Mound Treatment—Though not as effective as treating the entire area it can be used where the infestation is light or for temporary control. Tear down the mound with a rake or hoe and apply 1 to 2 cupfuls to the mound and to the ground within a 10 foot area on all sides. Do not apply to areas planted to food crops.

TICKS AND CHIGGERS: On lawns and recreational areas, apply at the rate of 20 pounds per acre or 8 OZ. per 1000 square feet. Treat only infested areas. One treatment made when infestation is first noticed will usually last all season. Apply with regular granular applicator, cyclone seeder or airplane.
