VISIBLE ALGAE GROWTH: Use 16 oz. of this product per 10,000 gallons of pool water

PREVENTION OF ALGAE: 8 oz. of this product per 10,000 gallons of pool water once every two weeks

### OR:

USE ONCE EVERY THREE MONTHS TO PREVENT ALGAE IN YOUR SWIMMING POOL PREVENTATIVE. Add 16 ft. oz. of this product per 10,000 gallons of pool water every three months to prevent algae growth in all pool types.

TREATMENT: Add 32 fl. oz. of this product per 10,000 gallons pool water for severe algae.

APPLICATION: This product comes concentrated. Dilute with at least nine parts of water before applying. Pour required amount of this product into a watering can and fill with water Maintaining continuous pool circulation, sprinkle solution around edge of pool. Apply under sunny conditions for most effective results.

TO CONTROL BLACK ALGAE: Use a black algaecide product as directed on the product's label. Once control is obtained, resume regular algaestatic maintenance with this product INITIAL POOL START-UP - Use a sequestering agent to prevent scale and stain formation.

WINTER DOSE: Add 16 oz. of this product per 10,000 gallons pool water.

Square or Rectangular Pools - L x W x D x 7.5 = Gallons

#### FIRST AID
