The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the **Busan 77 RED** and has concluded that your submission is acceptable.

NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

This pesticide is toxic to fish and aquatic organisms.

Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination Systems (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. This product is efficient, economical and stable in use dilution. It is compatible with most chemicals used in spa or hot tub water and will not damage tile, concrete, metal or plastics. Do not pre-mix with any foreign material; such as soap or other chemicals before application. This product works best when added [in several places] by itself directly to spa or hot tub water with the pump running. Wait 15 minutes before entry of swimmers. Clean spas or hot tubs with heavy growth of algae prior to using this product.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

INITIAL TREATMENT: For visible algae growth or slimy interior, add 6 - 8 ounces of this product for every 500 gallons of spa water. For best results, drain and clean spas containing heavy algae growth prior to treatment.

MAINTENANCE: After the initial treatment, keep your spa free of algae growth by adding 1 - 2 ounces for every 500 gallons of spa water every 5 - 7 days. This product is compatible with other spa chemicals. It can be used in conjunction with chlorine or bromine and may reduce the amount of those chemicals required.

IMPORTANT NOTE: Always apply chemicals separately. Never combine them. Do not mix with dry or liquid chlorine products.

STORAGE & DISPOSAL:

[Keep this product dry in its tightly closed container when not in use. Store in a cool, dry, wellventilated area. Keep away from heat or open flame. Nonrefillable container.
