Dear Joanna Holcombe:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Polixetonium Chloride Interim Decision, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling.

"To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. See FIFRA section 2(p)(2). If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process, FIFRA section 12(a)(1)(B). Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. 

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Wear butyl or nitrile rubber gloves. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.

FIRST AID

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and aquatic organisms.

Before draining a treated pool, contact your local sanitary sewer and storm drain authorities and follow their discharge instructions. Do not discharge treated pool water to any location that flows to a gutter or storm drain or natural water body unless discharge is allowed by state and local authorities.

This product is efficient, economical and stable in use dilution. It is compatible with most chemicals used in spa or hot tub water and will not damage tile, concrete, metal or plastics. Do not pre-mix with any foreign material, such as soap or other chemicals before application. This product works best when added [in several places] by itself directly to spa or hot tub water with the pump running. Wait 15 minutes before entry of swimmers. Clean spas or hot tubs with heavy growth of algae prior to using this product.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

INITIAL TREATMENT: For visible algae growth or slimy interior, add 6 - 8 fluid ounces of this product for every 500 gallons of spa water. For best results, drain and clean spas containing heavy algae growth prior to treatment.

MAINTENANCE: After the initial treatment, keep your spa free of algae growth by adding 1 - 2 fluid ounces for every 500 gallons of spa water every 5 - 7 days. This product is compatible with other spa chemicals. It can be used in conjunction with chlorine or bromine and may reduce the amount of those chemicals required.

IMPORTANT NOTE: Always apply chemicals separately. Never combine them. Do not mix with dry or liquid chlorine products.

STORAGE & DISPOSAL:

{*Nonrefillable container - household/residential use*}

[Keep this product dry in its tightly closed container when not in use. Store in a cool, dry, well-ventilated area. Keep away from heat or open flame. Nonrefillable container. Do not reuse or refill this container. Rinse empty container thoroughly with water to dissolve all material prior to disposal. Offer for recycling if available. Do not contaminate food or feed by storage or disposal or cleaning of equipment.]
