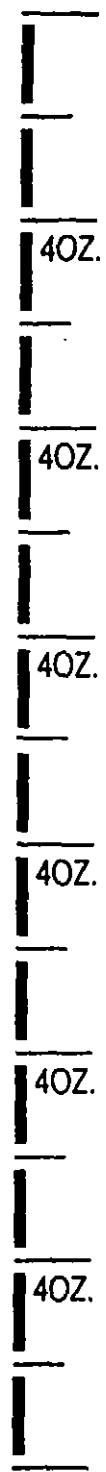

VISIBLE ALGAE GROWTH: 16 oz. POOLTRINE 60 per 10,000 gallons of pool water.

INITIAL CLEAN WATER TREATMENT: 9 oz. POOLTRINE 60 per 10,000 gallons of pool water.

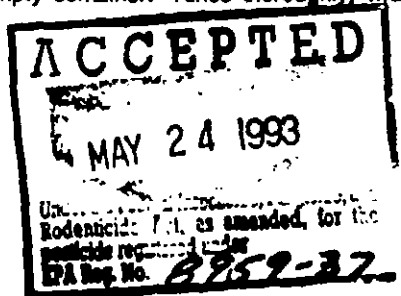
