To remove visible vellow or mustard aloae: (All dosages are for 10,000 gallons of water).

- 1. Brush walls and floor areas affected by yellow algae accumulations.
- 2. Apply 4 oz. (4 capfuls) of this product per 10,000 gallons as close to the affected areas as possible. For severe accumulations, double the above dosage.
- 3. Superchlorinate by adding 1 gallon liquid chlorinating compound or 1 lb, of a dry chlorinating compound per 10,000 gallons. Swimming may be resumed after a few hours of treatment.

WEEKLY MAINTENANCE TREATMENT:

To prevent accumulation of yellow algae: (All dosages are for 10,000 gallons of water).

- 1. With water temperature over 80 degrees, add 4 oz. (4 capfuls) of this product with 1 gallon liquid chlorinating compound or 1 lb. of a dry chlorinating compound once a week.
- 2. With water temperature under 80 degrees, add 2 oz. (2 capfuls) of this product weekly and ½ gallon liquid chlorinating compound or ½ lb. of a dry chlorinating compound.
