The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Inorganic Halides Interim Registration Review Decision, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised

labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

- 1. Brush walls and floor areas affected by yellow algae accumulations.
- 2. Apply 4 oz. [(1 capful)] of this product per 10,000 gallons as close to the affected areas as possible. For severe accumulations, double the above dosage.
- 3. Superchlorinate by adding [1 gallon liquid chlorinating compound or] 1 lb. (pound) of a dry chlorinating compound per 10,000 gallons. Swimming may be resumed a few hours after treatment.

WEEKLY MAINTENANCE TREATMENT:

To prevent accumulation of yellow algae:

(All dosages are for 10,000 gallons of water.)

- 1. With water temperature over 80 degrees, add 4 ounces [(1 capful)] of [brand or this product] with [1 gallon of liquid chlorinating compound or] 1 [lb. or pound) of a dry chlorinating compound once a week.
- 2. With water temperature under 80 degrees, add 2 ounces [(1/2 capful)] of [brand or this product] and [½ (one-half) gallon liquid chlorinating compound or] ½ lb. [or one-half pound] of a dry chlorinating compound once a week.

TO REMOVE VISIBLE YELLOW OR MUSTARD ALGAE:

- 1. Brush walls and floor areas affected by yellow algae accumulations.
- 2. Apply 6 oz. (1 pouch) of this product per 15,000 gallons of water as close to the affected areas as possible. For severe accumulations, double the above dosage.
- 3. Superchlorinate by adding [1½ gallon liquid chlorinating compound or] 1½ lb. (pound) of a dry chlorinating compound per 15,000 gallons. Swimming may be resumed a few hours after treatment.

WEEKLY MAINTENANCE TREATMENT:

TO PREVENT ACCUMULATION OF YELLOW ALGAE:

Add 6 ounces (1 pouch) of this product with [1½ gallon of liquid chlorinating compound or] 1½ pound of a dry chlorinating compound once a week.
