

FINTROL-5 is specially formulated for application to **shallow ponds, lakes, and reservoirs.** The active ingredient is released within the first 5 feet of depth. It can be applied by hand-operated or powered seed spreader mounted on a boat. Contents of this can will treat 6 acre-feet of water at 5 p.p.b.

FINTROL-5 can be used to eliminate all fish from a body of water (complete kill). Or, it can be used to remove only certain fish species or size groups from mixed populations (selective kill). It will effectively remove scale fish from catfish ponds.

IMPORTANT: The concentration of active ingredient required for effective results in a given situation depends upon the species to be eradicated, the water temperature, and the water pH.

Very low concentrations of **FINTROL-5** will usually kill sensitive species such as gizzard shad, trouts, pikes, carp, minnows, suckers, brook stickleback, white bass, sunfishes, perches, freshwater drum, and sculpins. Higher concentrations are required to kill more resistant species such as shortnose gar, bowfin, goldfish, and catfish.

Use of **FINTROL-5** does not impart detectable taste or odor to treated waters. Restocking can usually be done within a week after application.

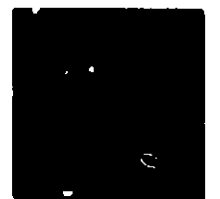
If the remaining contents of an opened can are not to be used immediately, the silica bag must be placed on top of the contents prior to resealing to protect the contents from moisture.



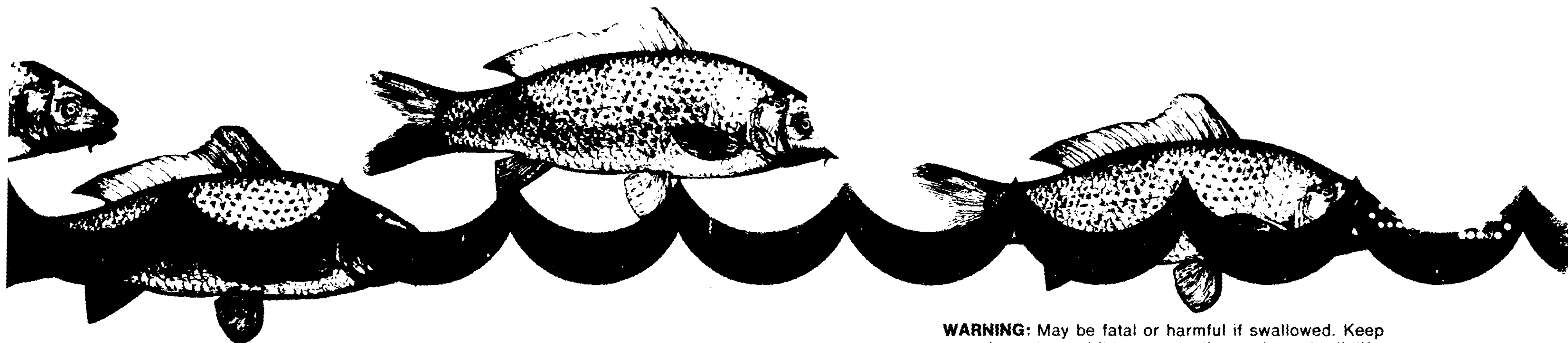
