Dear Mr. Van Blarcom:

Neither the revised basic Confidential Statement of Formula (CSF) dated 5/9/2004 referred to above, nor the revised CSF dated 7/1/2004 submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable. The concentration of the Active Ingredient is outside the limits of the accepted product.

The amended label referred to above, submitted July 19, 2004 in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable based on the accepted CSF dated 7/11/95 provided the following changes are made:

1. On the list of ingredients on both the bottle label and the card, make the following changes:
 - a. Put an asterisk after "Copper Sulfate Pentahydrate"
 - b. Change the concentration of copper sulfate pentahydrate from 1.61% to 6.34%.
 - c. Change the concentration of inert ingredients from 98.39% to 93.66%.
 - d. Under the "total" line, add: * metallic copper equivalent 1.60%
2. On the back panel of the bottle label, change "See card for storage and disposal details" to "See card for storage, disposal and first aid details"

One copy of the label stamped "Accepted with comments" is enclosed for your records. This label supercedes all labels previously accepted for this product. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.

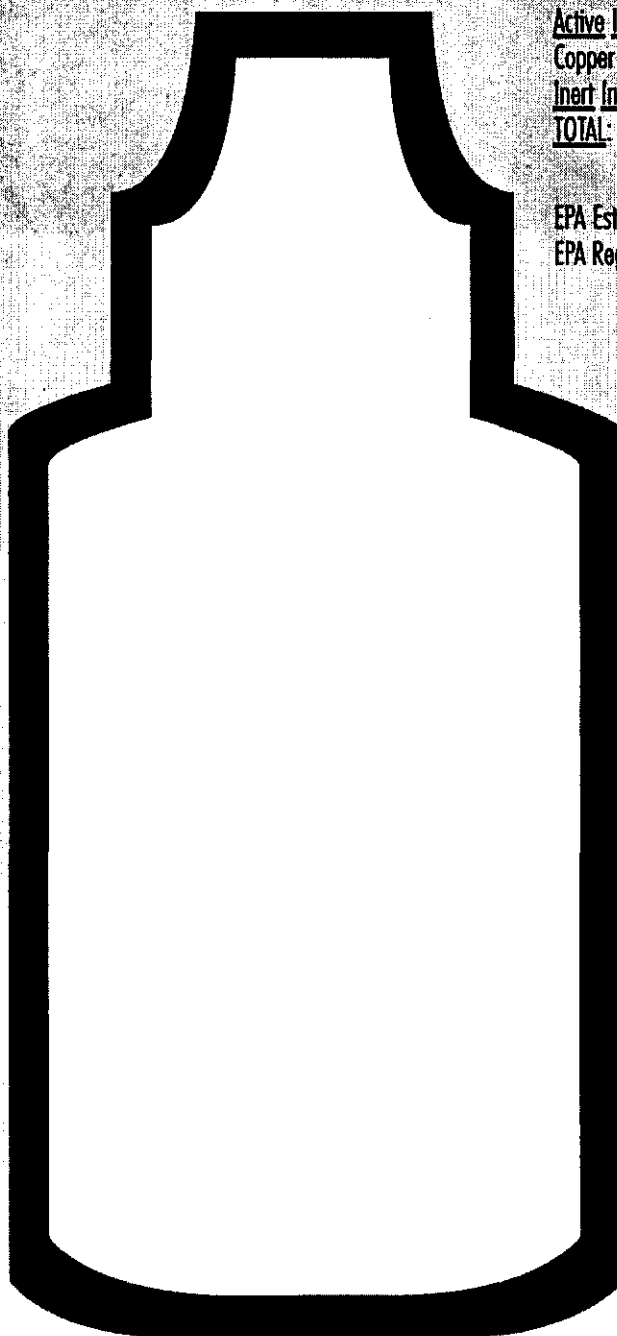

Shake well before using one drop per gallon of aquarium water (freshwater only). If second dose required, do 50% water change and retreat. Repeat second day. Product may be harmful to shrimp, crayfish, freshwater lobsters, invertebrates and amphibians. Care should be taken with live plants and catfish.

FIRST AID:

Have product container or label when calling poison control center, doctor, or going for medical treatment.

If Swallowed

- Call a poison control center or doctor immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told by a poison control center or doctor.
