Dear Ms. Bjornson:

The Agency has reviewed your application for amendment submitted in accordance with continuing registration under the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended, and determined the action acceptable with the following comments:

• The ingredient statement must have equal prominence so add bold typeface to "Other Ingredients" and "Total";

• Add "sealed" to the heading Asphalt or Wood Roofs and Sidings as marked;

• Under Sanitization of Non-Porous Food Contact Surfaces change "insure" to "ensure";

• Under Sanitization of Dialysis Machines correct the spelling of "in" as marked;

• On page 9, under the Fungicide, Virucide, and Disinfection headings change "treated" to "hard, non-porous";

- On page 10, change "Inanimate" to Non-porous as marked;
- At the first Optional Label Claim, change "treated" to hard, non-porous;
- At the second Optional Label Claim, insert hard, non-porous in front of "household";
- At the seventh Optional Label Claim, insert hard, non-porous in front of "in kitchens";
- At the ninth and tenth Optional Label Claims, change "treated" to hard, non-porous;
- At the thirteenth Optional Label Claim, delete "inanimate"; and,

• At the bottom of the Optional Label Claims, delete the asterisk and its associated claims.

In summary, your amendment to add the Fungicide claim and some additional marketing claims is acceptable. A stamped copy of the accepted labeling is enclosed. Submit one copy of your final printed labeling before distributing or selling the product bearing the revised labeling. # SANITIZATION

PUBLIC WATER SYSTEMS

RESERVOIRS: ALGAE CONTROL - Hypochlorinate streams feeding the reservoir. Suitable feeding points should be selected on each stream at least 50 yards upstream from the points of entry into the reservoir.

MAINS - Thoroughly flush section to be sanitized by discharging from hydrants. Permit water flow of at least 2.5 feet per minute to continue under pressure while injecting this product by means of a hypochlorinator. Stop water flow when a chlorine residual test of 50 PPM is obtained at the low-pressure end of the new main section after a 24-hour retention time. When chlorination is completed, the system must be flushed free of all heavily chlorinated water.

Close drain valves and hold under pressure for at least 10 minutes to ensure contact with all internal surfaces. Remove some cleaning solution from drain valve and test with a chlorine test kit. Prepare a 600-PPM solution by thoroughly mixing the product in a ratio of 13-oz. product with 10 gallons of water. Use spray or fogging equipment, which can resist hypochlorite solutions. Always empty and rinse spray/fog equipment with potable water after use. Thoroughly spray or fog all surfaces until wet, allowing excess sanitizer to drain. Vacate area for at least 2 hours. Prior to using equipment, rinse all surfaces treated with 600-PPM solution with a 200-PPM solution.

To Clean and Sanitize Milking Equipment AND UTENSILS: It is important to clean out large deposits of milk or other organic before applying this product/water solution.
