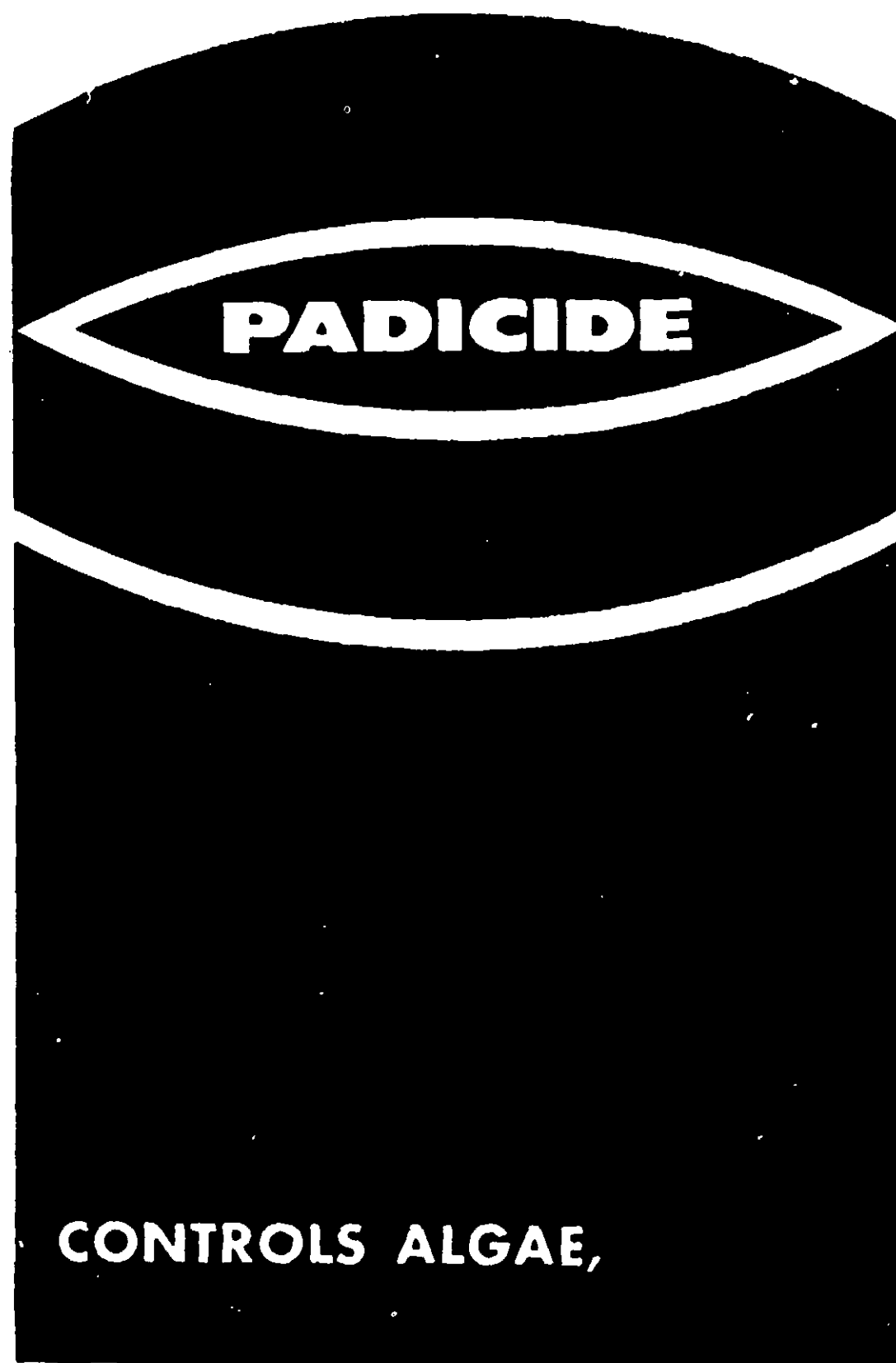

DILUTION DIRECTIONS:

SWIMMING POOLS: PADCIDE is excellent for ALGAE CONTROL. Initial dosage, one quart in the average 20,000 gallon clean home pool. For continued control add 1 cup (8 fluid oz.) per 20,000 gallons of water per week depending on pool usage, size, and local contamination factors. In case of black algae already in pool, use PADCIDE at 10 ppm active ingredients for control. USE: 1 gallon PADCIDE per 20,000 gallons of pool water. Remove settled or killed algae; then apply the initial dose of 1 quart PADCIDE per 20,000 gallons of pool water. May be poured into pool at any time.

OTHER THAN POOLS: Sanitation of poolside accessories is important. Apply as final rinse.

Disinfecting deodorizing solution: After cleaning poolside surface areas apply solution containing one tablespoon PADCIDE per 2 gallons of water.
