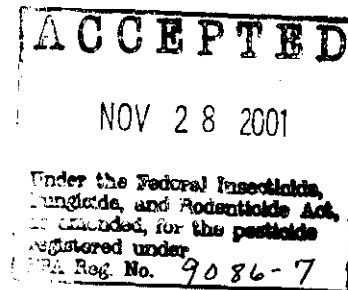

GENERAL INFORMATION

The Revenge Liquid Bait Ant Killer Destroys the Entire Ant Colony. Use Revenge in the immediate area around home, indoors, patio, play yard and garage. Place product where ants are seen.

GENERAL PRECAUTIONS AND RESTRICTIONS

Children and pets should not be in treatment area until after application is completed. Do not treat pets with this product. Avoid contamination of feed and foodstuff. Avoid contamination of ornamental plants.

APPLICATION INSTRUCTIONS

1. Tear off and use all the bait pads. The more bait available, the faster the control.
2. Fill center of pad with liquid ant bait and place where ants are seen.
3. Refill all bait pads daily or as needed.
4. Discard bait pads when ants are no longer seen.

EXTRA TIPS

FOR SWEET EATING ANTS: Place a few drops of Revenge where ever ants are seen and in the mouth of ant

hills. Ants will carry bait to nests. Repeat as needed or twice monthly as a preventative.

FOR GREASE EATING ANTS: Mix one or two drops of salad oil with a few drops of Revenge and place where ever ants are seen.

BAIT PADS: If you run out of bait pads, just use other Small pieces of cardboard, wax paper or foil.
