**1. FOR CONTROL OF BACTERIA AND ALGAE (OUTDOORS) IN SPAS OPERATED
CONTINUOUSLY:** Before bathing, test water pH, chlorine residual and alkalinity
using a suitable test kit. Adjust chlorine residual to 3.0 ppm. Maintain pH of water
between 7.2-7.8 and total alkalinity between 125 and 175 ppm with the addition of
Spa-care pH Stabilizer.

2. This product does not affect pH or alkalinity of water. One tablet (1/4 oz.) per
1000 gal. of water gives 3 ppm of chlorine. To use apply sufficient tablets to the
feeder to maintain the chlorine level at 1 to 3 ppm. Bathing can start when the
chlorine level is between 1 and 3 ppm.

**3. Test often and keep chlorine residual above 1.0 ppm by adjusting output from
feeder to bathers load.**

**4. Weekly, superchlorinate water to 5 x 6 ppm using E-2 TABS as recommended
on the label directions.** Usually 1 E-2 TAB per 500 gal. of water gives 6 ppm
chlorine. Draining and cleaning of spa is recommended whenever the water
becomes difficult to manage. Avoid use of products such as body lotion that con-
sume chlorine.
