This is in response to your amendment to revise label to include the use directions, precautionary statement, practical treatment statement, and storage & disposal statement.

The labeling referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended is acceptable provided that you make the following revisions before you release the product for shipment bearing the amended labeling.

1. In the Statement of Practical Treatment, include the following:

"If Inhaled: Remove patient to fresh air. If not breathing, give artificial respiration. If breathing is difficult give oxygen. Get immediate medical attention".

- Include the signal word "Warning" immediately below "Keep Out of Reach of Children".
- 3. Include the statement "This pesticide is toxic to fish" as the first statement under Environmental Hazards.
