Keep out of reach of children. Avoid breathing spray mist. Ventilate area after treatment. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in kitchens, restaurants, or areas where food is prepared or served, apply only when the facility is not in operation. Cover fish bowls and remove pets when spraying rooms. Do not spray on animals or plants. Do not spray directly on plastic or asphalt, tile or linoleum as ingredients may be harmful to some such surfaces.

DIRECTIONS: Remove protective cap. Hold dispenser upright and press button to release mist. Always hold dispenser at least three feet from any object or surface when spraying. **Flying Insects:** flies, mosquitoes, wasps, flying moths, gnats: Shut doors and windows and spray up into air with a sweeping motion at the rate of three to five seconds per 1000 cubic feet. Keep room closed for at least fifteen minutes after spraying. **Crawling Insects:** roaches, silverfish, waterbugs, crickets: spray hiding places such as baseboards, openings around sinks, drains and pipes. Also secluded places. Spray directly on these insects whenever possible. Repeat as needed. **Spiders and Centipedes:** spray webs and other places where these pests crawl. Spray directly on as many of these insects as possible. Repeat as needed. **Bedbugs:** dismantle bed and spray into all joints. Spray baseboards, moldings, spray mattresses particularly around seams, tufts, and folds. Hold container at least three feet from light colored surfaces. Repeat as needed. **Ants:** spray directly at insects and ant trails, hills, and other places where ants congregate. **Fleas:** spray floors, floor coverings, and sleeping quarters of pet. Repeat as often as needed. **Do not spray pets.**

Active Ingredients: Pyrethrins 0.5%. Technical Piperonyl Butoxide* 1.0% N-Octyl Bicycloheptene Dicarboximide 1.67%. Petroleum Distillate 16.83%.

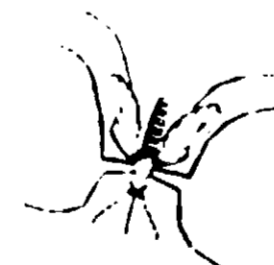
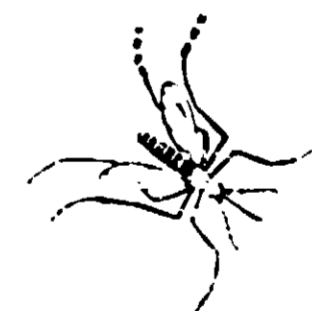
