

DIRECTIONS FOR USE

For control of the following insects in homes, factories, offices, food processing plants, institutions and similar environments apply as follows.

For outdoor application only.

ROACHES, ANTS, SILVERFISH, WATER BUGS, SPIDERS, CRICKETS: Direct spray into cracks, on baseboards, window and door trim, under cabinets, stoves, sinks, and around pipes. Spray surfaces until wet. Repeat as necessary.

MOSQUITOES, FLIES, WASPS AND CERTAIN OTHER FLYING INSECTS: Spray on surfaces of screens, doors and window frames, porches, light fixtures, garages and other places where these insects alight, congregate, or wherever insects may enter room.

CAUTION: Harmful if swallowed. Keep out of reach of children. Avoid breathing spray mist or contact with skin. Contact with skin can cause toxic symptoms. Wash with soap and water after using. Avoid contamination of feed and foodstuffs. Do not use on household pets. Do not spray heavily on asphalt tile or linoleum, as ingredients may be harmful to some such surfaces.
