Apply this product only as specified on the label. Remove protective cap from top of can. Hold can upright, point opening in valve in desired direction for spray. To release spray, press valve downward or push valve forward. FLIES, MOSQUITOES, GNATS: Spray upwards into four corners of closed room, to fill the room with spray mist.
