#### DIRECTIONS FOR USE

**KILLS EVEN RESISTANT ROACHES:** For use indoors or outdoors. Hold can upright and spray infested surfaces only until wet. **ROACHES, ANTS, WATERBUGS, SILVER-FISH, SPIDERS, FIREBRATS, CRICKETS:** Spray until wet surfaces behind and beneath cabinets, refrigerators, sinks, stoves, trails, and other localized areas infested with insects. Spray around window and door frames where ants enter. Repeat as necessary. **CARPET BEETLES:** Make localized application to areas of the floor and baseboards.
