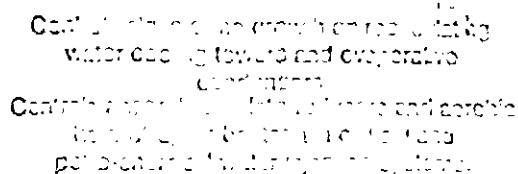

OIL FIELD AND PETROCHEMICAL SUBSURFACE PRODUCTION SYSTEMS—Diverse requirements vary from site to site. Areas frequently requiring control are low water sources, mixing tanks, separators and the formation itself. SLUG DOSES: An effective treatment for aerobic heterotrophic bacteria is 200-600 ppm THIS PRODUCT (20 to 100 ounces per 1,000 gallons). A slug dose for anaerobic sulfate-reducers is 60-250 ppm of this Algaecide (6 to 30 ounces per 1,000 gallons). The appropriate slug dose should be applied for 10 to 18 hours daily until the desired level of control is achieved. To maintain the system in an acceptable manner, utilize a continuous treatment with the addition of apply only to the target disease.

INTERMITTENT DOSES: To prevent a clean system from fouling, slug doses may be applied intermittently. The frequency of intermittent doses will vary with individual systems and can be established only through experience. Intermittent doses may be required 2 to 3 times a week in some systems. Other systems may require dosing once a week or once every two weeks. For heterotrophic bacteria, use 200-600 ppm THIS PRODUCT (2.0 to 103 ounces per 1,000 gallons). For aerobic sulfate-reducers, use 60-200 ppm THIS PRODUCT (3 to 30 ounces per 1,000 gallons). Maintain these doses for two to eight hours, depending upon the requirements of your system.

CONTINUOUS TREATMENT: Failed systems should be repaired to permit continuous treatment. If the system is not repaired, the system should be shut down and the treatment plant should be notified.
