## GENERAL PEST CONTROL INDOORS

TREAT THE INSIDE OF YOUR HOME TO KILL ROACHES, ANTS, WATERBUGS, SPIDERS, SILVERFISH, BROWN DOG TICKS, EARWIGS, CRICKETS AND FLEAS AND SCORPIONS. TO TREAT THE KITCHEN AREA: Spray all baseboards, under the sink, behind and under all large appliances. Spray cabinets, window frames and wall area around drain board. BE VERY CAREFUL NOT TO CONTAMINATE FOOD, WATER, DISHES OR UTENSILS. Spray cracks and crevices where insects may hide. NEXT, TREAT THE BATHROOM: Spray baseboards and window frames and under lavatory.
