Subject: The Andersons Fertilizer with 5.5% Dacthal
EPA Registration No. 9198-24
Application Dated December 30, 1994, Request To
Amend Labeling by Adding WPS Exclusionary Statement
and Using Split Labeling

The proposed labeling submitted with your application dated December 30, 1994 has been reviewed and found acceptable under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended, provided that:

1. Add the same exclusionary statement to the "homeowner use only" labeling as the one you added to the "Commercial Use Only" labeling submitted with this application.
2. Correct the spelling of the names of the weed pests controlled. On both labels the weed: Florida pusley must be spelled correctly. On the "homeowner Use only" label correct the spelling of purslane, florida pusley, and lovegrass (lavatories). We would have no objection to your adding lovegrass to both labels.
3. Submit one (1) copy of the final printed labels before releasing the product for shipment under the subject labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copies of the labeling are enclosed for your records.

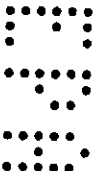
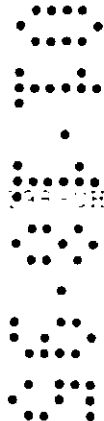

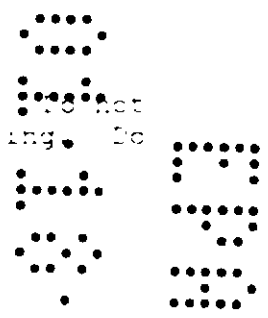

DIRECTIONS FOR USE

It is in violation of Federal Law to use this product in a manner inconsistent with its labelling.

Apply at the rate of 3.33 to 6.25 pounds per 1,000 square feet, or the equivalent of 9 to 15 pounds actual Dacthal per acre. At these rates, this product will control smooth and hairy crabgrass. Apply this product prior to germination of crabgrass seeds. In the northern states, this would be during the period of January 1 through April 30.

Apply at the rate of 5 to 6.25 pounds per 1,000 square feet, or the equivalent of 12 to 15 pounds actual Dacthal per acre. At these rates, this product will control green and yellow foxtail, lavaterias, waterhemp, carpetweed, smartweed, lambsquarters, persiane, and flintweed.

Note: Higher rates should be used in areas of heavy infestation.

USE PRECAUTIONS

DO NOT APPLY IN SUFFOLK COUNTY, LONG ISLAND, NEW YORK.

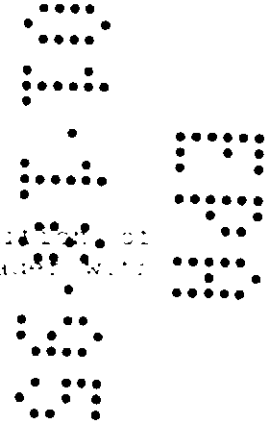
Do not apply to bentgrass or dichondra. Do not apply to newly seeded areas. Do not reseed within 60 days after application.

GROUNDWATER ADVISORY: Tetrachloroterephthalic acid, a breakdown product of Dacthal, is known to leach through soil as a result of agricultural and turf uses and has been found in groundwater which may be used for drinking water. Users are advised not to apply Dacthal to sand and loamy sand soils where the water table (groundwater) is close to the surface and where these soils are very permeable, i.e. well drained. Your local agricultural agencies can provide further information on the type of soil in your area and the location of groundwater used for drinking water.
