NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Bees exposed to direct treatment or residues on plants are highly susceptible. Do not apply directly to water. Keep out of lakes, streams and ponds. Do not contaminate water by disposing of equipment washings. Do not apply when weather conditions favor drift from areas treated. Do not apply where runoff is likely to occur.

### DIRECTIONS FOR USE

It is in violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### SURFACE INSECT CONTROL

Apply at the rate of 2 lbs. per 1000 square feet, or the equivalent of 1 lb. actual active ingredient per acre. At this rate, the product will control chinch bugs, sod webworms (lawn moths), ants, brown dog ticks, crickets, cutworms, earwigs, grasshoppers, armyworms, centipedes, clover mites, fiery skipper, fleas, greenbugs, June beetles, leafhoppers, millipedes, mites, mosquitoes, sowbugs and ticks.

Treat when insects first appear, re-treat as necessary. For best results, product should be watered in after application.

#### GRUB CONTROL

Apply at the rate of 4.0-7.8 lbs. per 1,000 square feet, or the equivalent of 2-4 lbs. actual active ingredient per acre. At this rate, the product will control certain white grubs (larvae of European chafer and Japanese beetle).


Treat when grubs are young and actively feeding near the soil surface. Consult your local Agricultural Extension Service for proper time to treat in your area. For best results, product should be thoroughly watered in to wash the insecticide into the zone of insect infestation.

To control Hyperodes (turfgrass) weevils, uniformly apply 4 pounds of granules per 1,000 sq. ft. as directed above. Treat suspected problem areas in mid-April and again in mid-May. Consult your local Agricultural Extension Service specialists for best time to treat in your area.
