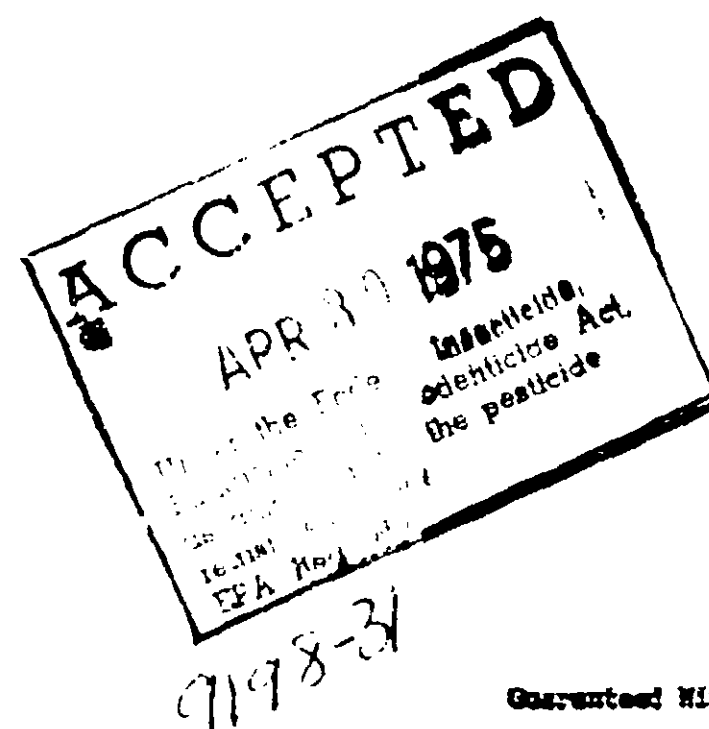

Application: Apply at the rate of 2.8 lbs. per 1000 square feet, or the equivalent of 1.13 actual chlorpyrifos per acre. At this rate, this product will control chinch bugs, sod webworms (lawnmoths), ants, brown dog ticks, crickets, cutworms, earwigs.
