Dear Mr. Paradiso:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Add the words

For use on turf

immediately below the brand name of the product.

(Please note that we review, and use the "Accepted" stamp, only on labeling that bears the official name of record of the product. We have accepted several additional brand names for the product. You may use these if no other changes are made to the labeling.)

2. Revise the Environmental Hazards [For Homeowner Use:] section to:

This pesticide is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water. Runoff may be hazardous to aquatic organisms in neighboring areas.

Do not contaminate water when disposing of equipment washwaters.

3. Revise the Environmental Hazards [For Commercial Use:] section to:

This pesticide is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters.

4. In the Directions for Use, immediately below the sentence, "It is a violation of Federal Law..." add the following restriction:

Not for use on turf being grown for sale or commercial seed production, or for research purposes. For use on turf intended for aesthetic purposes or climatic modification and being grown in ornamental gardens or parks, or on golf courses or lawns or grounds.

(This restriction is necessary to remove the product from the scope of the Worker Protection Standard.)

Submit five (5) copies of your final printed labeling before you release the product for shipment.

Treat when insects first appear, re-treat as necessary. For best results, product should be watered in after application.

GRUB CONTROL

Apply at the rate of 2.0-3.7 lbs. per 1000 square feet. At this rate, the product will control certain white grubs (larvae of European chaffer and Japan'se beetle). Treat when grubs are young and actively feeding near the soil surface. Consult your local agricultural extension service for proper time to treat in your area. For best results, product should be thoroughly watered in to wash'the insecticide into the zone of insect infestation.

To control Hyperodes (turfgrass) weevils, uniformly apply 2 pounds of granules per 1,000 sq. ft. as directed above. Treat suspected problem areas in mid-April and again in mid-May. Consult your local Agricultural Extension Service specialists for best time to treat in your area.
