



OVERALL LAWN APPLICATION

Turf Care Granular Insect Control plus Lawn Food controls the following lawn insects on both grass and dichondra lawns:

Chinch bugs - Earwigs - Ants - Lawn moths (Sod webworms) - Bermuda mites - Crickets - Armyworms - Chiggers - Clover mites - Cutworms - Leafhoppers - Sowbugs - Millipedes - Springtails (Collembola).

Apply Turf Care Granular Insect Control plus Lawn Food to your lawn with a fertilizer spreader at the rates shown. Application should be made when grass is dry. Water lawn lightly after application. Repeat as necessary.

Apply at the rate of 2.7 lbs. per 1000 sq. ft. (an area 20' by 50').

BILLBUGS, WHITE GRUBS OF JAPANESE BEETLE, EUROPEAN CHAFER, SOUTHERN CHAFER

Apply 3.2 lbs. per 1000 sq. ft. of lawn. Water grass thoroughly after application. For grub control make application any time between late July and early October. For billbug control, apply when activity is first observed or when chewed or brown grass indicates damage from these insects. Repeat as necessary.

HYPERODES WEEVIL (NEW YORK ONLY)

Apply 2.7 lbs. per 1000 sq. ft. of grass. Water grass thoroughly after application. Treat problem areas in mid-April and again in mid-May.

DISPOSAL

Do not reuse empty container. Wrap container and put in trash collection.
