

Ontrol is slower if weather is cool. Applications in Spring and Fall provide most effective kill. Apply when lawn is wet from rain, dew or sprinkling. On newly seeded areas, wait until grass has been cut two or three times. Delay planting new grass for at least 3 weeks as 2,4-D may temporarily inhibit seed germination or plant growth. Do not apply when turf is under stress from heat, moisture or drought. Do not cover or under apply.

HOW TO APPLY

Apply evenly over entire lawn area at the rate of 3-4 lbs. per 1000 sq. ft. Use the suggested spreader settings as a guide being sure to check your spreader settings at the beginning of the application. Age and condition of spreader will affect application. Adjust your spreader if necessary. Be sure to shut off spreader while turning or stopping to prevent accidental over-application and burning of grass.
