Subject: Amendment - Label Revision - Addition of Mole Cricket Control  
Turf Care Lawn and Garden Insecticide  
EPA Registration No. 9198-62  
Your Letter Dated March 28, 1985

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3(c)(7)(A) is acceptable provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
  - a. Under the heading Precautionary Statements, insert "with soap and water," after "wash thoroughly."
  - b. Immediately following, If swallowed, add the sentence, "Call a physician or Poison Control Center."
  - c. Under the subheading, If in eyes, insert the wording, "with plenty of water," following "Flush eyes . . . ."
  - d. Under the heading Storage and Disposal, add the sentence, "Do not contaminate water, food, or feed by storage or disposal."
  - e. Under the heading Storage and Disposal, the subheadings Pesticide Disposal and Container Disposal need to be listed. They should stand out with bold type or by some other means. Immediately following Pesticide Disposal, the sentence "Securely wrap original

container in several layers of newspaper and discard in trash," must be used. The sentences, "Do not reuse bag. Discard bag in trash," should be used for the Container Disposal subheading.

3. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.



The above spreader settings are approximate. Differences may occur due to condition of spreader, speed at which applied and roughness of terrain. Calculate the size of the area to be treated and do not over-or under-apply. Accurately weigh a few pounds into your spreader and apply to a measured area. Then adjust the spreader settings, if necessary, in order to assure correct rate of application. Close spreader when filling, stopping or turning. Do not hand spread.
