For control of crabgrass, apply at the recommended rate (see RATES OF /PPLICATION) any time from fall (September or October) through early spring for spring and summer control. With a late winter or an early spring application, the application must be made prior to crabgrass emergence (see PRODUCT INFORMATION).

Consult weed specialists of the State Agricultural Extension Service or the State Agricultural Experiment Stations for additional information, as the timing of application will vary with local conditions.
