Dear Registrant:

The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, successfully **REMOVES THE PRODUCT FROM THE SCOPE** of PR Notice 93-7 one the comments (if any) on the attached sheet are addressed. Other than the alterations (if any) listed on the attached sheet, no further alterations to the labeling are necessary to reflect the requirements of the Worker Protection Standard.

Since your amendment proposes to delete uses directly and/or to delete uses implicitly through the use of exclusionary statements), the Agency will publish in the Federal Register a notice of receipt of your amendment to delete uses, as required by section 6(f)(1) of FIFRA. The Agency will defer action for 90 days from the date of the Federal Register notice to give affected minor users an opportunity to try to persuade you to retain the uses(s). When the comment period has expired, the Agency will approve the amendment unless you have withdrawn it, and stamp the amended labeling "accepted." Your stamped-accepted labeling will then be sent to you.

As described in Supplement A of PR Notice 93-11 (self-verification option), you may sell and distribute product bearing the submitted labeling before you receive a copy of your stampedaccepted labeling. Note that your registration is not amended until the comment period required by section 6(f)(1) of FIFRA has expired and the Agency has approved the amendment. Therefore, you may withdraw your proposed amendment at any time during the comment period and until you receive your stamped-accepted labeling.

For control of crabgrass, apply at the recommended rate (see RATES OF APPLICATION) any time from fall (September or October) through early spring for spring and summer control. With a late winter or an early spring application, the application must be made prior to crabgrass emergence (see PRODUCT INFORMATION).

Consult weed specialists of the State Agricultural Extension Service or the State Agricultural Experiment Stations for additional information, as the timing of application will vary with local conditions.

Where germination of crabgrass extends into the late summer and early fall, a second application at the recommended rate should be made 4 to 5 months after the initial application.

RATES OF APPLICATION

CRABGRASS ONLY: Apply 3.75 to 5 pounds of Custom Mix 25-6-10 with Betasan uniformly on 1,000 square feet. This will give .93 to 1.25 pounds of nitrogen per 1,000 square feet.

Sprinkle the area with water for 10 to 15 minutes after application to wash the material down into the soil where the crabgrass seeds are located.

SUGGESTED SPREADER SETTINGS

(AVAILABLE AT LABEL PRINTING)

Important: These settings are only approximate. Age and condition of spreader can cause wide variation. Be sure to calibrate your spreader with each application.

RESEEDING

Any material that provides effect_ve control of annual grasses may affect new lawn grass seedlings which germinate after treatment. Proper fertilization and watering will encourage the existing turf grass to fill in the thin or bare spots fomerly occupied by crabgrass.

The following procedures are suggested in order to minimize any stunting of turf grasses which may occur when reseeding into BETASAN-treated areas:

- 1. Do not reseed within 4 months after application.
- Renovate the area to be reseeded by raking throughly to scarify the soil surface. Where practical, mix peat in with the soil to provide an optimum seed bed.
- 3. When turf diseases or physiological disorders necessitate reseeding sooner than 4 months after application. apply powered activated charcoal prior to to reseeding to deactivate the Professional Custom Mix 25-6-10 with Betasan.

Apply the activated charcoal at a rate of 7 pounds in 14 gallons of water per 1,000 square feet (333 pounds in 600 gallons of water per acre).

Following application, irrigate the turf with sufficient water to wash the charcoal into the soil.

Reseed no sooner than 7 days after applying the charcoal. STORAGE AND DISPOSAL

Store in a dry place. Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Completely empty bag into application equipment.
