Dear Registrant:

The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, successfully **REMOVES THE PRODUCT FROM THE SCOPE** of PR Notice 93-7 once the comments (if any) on the attached sheet are addressed. Other than the alterations (if any) listed on the attached sheet, no further alterations to the labeling are necessary to reflect the requirements of the Worker Protection Standard.

Since your amendment proposes to delete uses directly and/or to delete uses implicitly through the use of exclusionary statements), the Agency will publish in the Federal Register a notice of receipt of your amendment to delete uses, as required by section 6(f)(1) of FIFRA. The Agency will defer action for 90 days from the date of the Federal Register notice to give affected minor users an opportunity to try to persuade you to retain the uses(s). When the comment period has expired, the Agency will approve the amendment unless you have withdrawn it, and stamp the amended labeling "accepted." Your stamped-accepted labeling will then be sent to you.

As described in Supplement A of PR Notice 93-11 (self-verification option), you may sell and distribute product bearing the submitted labeling before you receive a copy of your stamped-accepted labeling. Note that your registration is not amended until the comment period required by section 6(f)(1) of FIFRA has expired and the Agency has approved the amendment. Therefore, you may withdraw your proposed amendment at any time during the comment period and until you receive your stamped-accepted labeling.

HAZARDS TO HUMANS & DOMESTIC ANIMALS

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Not for use on plants being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

### USE PRECAUTIONS

Do not allow spray to drift to vegetables, flowers, ornamental plants, shrubs, trees and other desirable plants since injury may result. Do not spray where grass is emerging from dormancy or where grass is newly seeded. Do not spray when the temperature exceeds 85°F. Allow 24 hours until dry before letting pets and children on the lawn. Seed can be safely sown 3-4 weeks after applications. Do not use on carpetgrass, dichondra, St. Augustine, Centipede, closely-mowed bentgrass nor where desirable clovers are present. Do not spray roots of trees and ornamentals. Do not exceed specified dosages for any area; be particularly careful within dripline of trees and other ornamental species.

### WHEN TO USE

1. Spray at any time during the growing season when weeds are actively growing. Spray works faster when temperature exceeds 70 degrees. 2. On new lawns, wait until the grass has reached a height of 2 inches before making an overall spray treatment. Wait 3 weeks before putting new grass seed or stolons down in the bare spots. 3. In areas where drought persists, water the lawn thoroughly, and wait 24 hours to apply GREENSWEEP Weed & Feed. After an additional 24 hours, water again. 4. For best results, mow 1 to 2 days before treating. 5. GREENSWEEP Weed & Feed should be supplemented by GREENSWEEP Lawn Food every three weeks from March through September. Please consult your local extension office for questions regarding additional fertilizer needs in your area.

### HOW TO APPLY

Shake well before applying -Connect spray nozzle to hose-Remove bottle cap and screw bottle onto nozzle-Turn the on/off switch on top of the nozzle right or left to OFF-Turn on the water at the tap-When ready to treat, turn the on/off switch to its center ON position. The water mixes automatically with the GREENSWEEP at the proper ratio-Walk and spray at a steady pace. Marks on side of bottle indicate square feet covered in 1000's. The maximum number of broadcast applications per treatment site is 2 per year.

#### One-Quart Ready-To-Use Container
