d. Revise the ENVIRONMENTAL HAZARDS section to:

This pesticide is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters.

Do not take internally. Do not breathe dust. Avoid contact with skin, eyes, or clothing. May be absorbed through the skin. Wear long sleeves. Change clothing daily. Wash hands thoroughly after handling. Keep children and pets off treated area during irrigation and until area has dried. Avoid contamination of feed and foodstuffs. IF SWALLOWED: Drink two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention.

IF IN EYES: Flush eyes with plenty of water and get prompt medical attention.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

SURFACE INSECT CONTROL

Apply at the rate of 1 lb. per 1,000 square feet. At this rate, the product will control chinch bugs, sod webworm (lawn moths), ants, brown dog ticks, crickets, cutworms, earwigs, grasshoppers, armyworms, centipedes, clover mites, fiery skipper, fleas, greenbugs, June beetles, leafhoppers, millipedes, mites, mosquitoes, sowbugs and ticks.

Treat when insects first appear, re-treat as necessary. For best results, product should be watered in after application.

GRUB CONTROL

Apply at the rate of 2.2 lbs. per 1,000 square feet. At this rate, the product will control certain white grubs (larvae of European chaffer and Japanese beetle). When high populations of grubs are present in the area to be treated, a repeat application of 2.2 lbs. per 1,000 sq. ft. may be made 7 to 14 days following the initial application. Treat when grubs are young and actively feeding near the soil surface. Consult your local agricultural extension service for proper time to treat in your area. For best results, product should be thoroughly watered in to wash the insecticide into the zone of insect infestation.

To control Hyperodes (turfgrass) weevils, uniformly apply 2 lbs. of granules per 1,000 sq. ft. as directed above. Treat suspected problem areas in mid-April and again in mid-May. Consult your local Agricultural Extension Service specialists for best time to treat in your area.
