#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Not for use on turf being grown for sale or other commercial use as sod, or grass grown for seed, or for research purposes or on golf courses.

In New York State, the product may NOT be applied to any grass or turf areas within 100 feet of a water body (lake, pond, river, stream, wetland or drainage ditch). In New York State, do make a single repeat application of this product if there are signs of renewed insect activity, but not sooner that two weeks after the first application.

Do not apply more than 400 lbs. of this product per acre (0.2 lbs. active ingredient per acre / 9.2 lbs. of product per 1,000 sq.ft.) per year.

Do not allow children and pets to enter the treated area until dry.

Treat when insects first appear. Apply this product at a rate of 2 to 4 pounds per 1000 square feet evenly over the turfgrass area using a properly calibrated drop or rotary spreader. Check frequently to make sure the equipment is working properly and the granules are being evenly َوْرُ وَ distributed. A more uniform application may be achieved by spreading half of the required amount of product cver the area and then applying the remaining half in swaths at a right angle to the first.



Best results will occur if the treated area is thoroughly irrigated with water immediately after application.

For more difficult to control pests such as ants, fleas, imported fire ants, mole crickets and ticks, a higher application rate may be needed. In this case, apply 4 to 8 pounds per 1000 square feet.

#### Comments:

Armyworms, Cutworms, and Sod Webworms: For best results, the treated area should be irrigated immediately after application with up to 0.1 inches of water to activate the insecticide.

Annual Bluegrass Weevil: Treatment should be made to control the adult weevils as they migrate from their overwintering sites and move into grass areas. Contact your State Cooperative Extension Service for more specific information.

Billbugs: Apply when adult billbugs are first observed during April and May. Consult your State Cooperative Extension Service for information on degree days and timing in your region.

Black Turfgrass Ataenius: Apply treatments during May and July to control both generations of adults. The May application should be made at the same time as the full bloom stage of Vanhoutte spiraea and the Horse chestnut. The July application should coincide with the blooming of Rose of Sharon.

Chinch Bugs: These bugs infest the base of the plant and are usually found in the thatch layer. Watering the treated area with up .25 inches immediately after application will result in quicker control.

Flea Larvae: These larvae develop in the soil and shady areas. Irrigate the treated area with up to 0.5 inches of water immediately after application.

Imported Fire Ants: The best control will be reached by a combination of broadcast applications and mound drenching. When mound drenching, a product such as Talstar Lawn and Tree Flowable, must be used. Irrigation should be performed prior to application if the soil is not moist. For best results, apply in cool weather. The early morning or late evening hours should suffice.

Mole Cricket Adults: These adults can be difficult to control because of their extremely active stage in the early spring. Applications should be made as late in the day as possible and be watered up to 0.5 inches immediately after treatment. If the soil is not moist prior to application, it should be irrigated to ensure best control.

Mole Cricket Nymphs: Optimum control can be reached by treating young nymphs because they are more susceptible to the insecticide. Irrigate soil if it is not moist before application. Treatment should be made as late in the day as possible. Water the treated area with up to 0.5 inches directly after application.

Ticks: Do not make spot applications. Treat the entire area where ticks may occur. The higher application rate might be needed if heavy leaf litter or dense ground cover exists. Retreatment might also be necessary due to animals reintroducing new populations.

Deer Ticks: These ticks have a life cycle that ranges over a two year period and involves four life stages. Treatments should be applied in mid- to late-spring to control larvae and properties that are present on the soil.

American Dog Ticks: These ticks tend to gather along paths or roadways where humans are likely to be found.

These suggested spreader settings are not intended to replace calibration.
