Subject: Label Amendment: First Aid, Disposal, etc. The Anderson Golf Products Insecticide III EPA Reg. No. 9198-167 Submissions dated November 13, 2002, accepted with comments.

Dear Ms. Walters:

The labeling referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments specified this letter as listed below:

1) In the absence of actual toxicological data which will be required for reregistration we assume toxicological category III. Revise the Precautionary Statements and begin with "Harmful if swallowed, inhaled or absorbed through the skin. Causes moderate eye irritation. Avoid Breathing Dust. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash thoroughly before reuse".

2) Add under the Directions for Use "Do not allow the public, especially children, on treated areas during treatment and until the pesticide is washed into the soil and the turf is completely dry".

3) Add to the Storage and Disposal statement below the title "Do not contaminate water, food or feed by storage and disposal.

4) For use on turfgrass or dichondra on golf courses or delete the sentence.

5) Replace "sprinkle" with "water" under Ant, Tick......

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

For use on turfgrass or dichondra

Controls chinch bugs and other insects listed below:

Ant	Flea beetle (in dichondra)
Brown dog tick	Grasshopper
Cricket	Hyperodes weevil
Cutworm	Sod webworm (lawn moth larvae)
Earwig	Vegetable weevil (in dichondra)

Apply over entire area. Overlap spreader wheel tracks so no strips are missed.

Water as recommended after each application to wash product particles into the zone of insect activity. Do not mow or collect clippings for 24 hours after treatment.

CHINCH BUG control - apply any time activity or damage is noticed. Water thoroughly (1/4 to 1/2 inch) after each application.
