
The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. Change heading "If On Skin" to "If On Skin Or Clothing" under First Aid Statements.
2. It is recommended that the location of the Ingredient Statement is moved to immediately below the product name.
3. Add "Keep children and domestic animals off treated areas until dust has settled" to DIRECTIONS FOR USE section under the heading "Entry Restrictions."
4. Change "Storage" to "Pesticide Storage" under STORAGE AND DISPOSAL.
5. Remove the repeat sentence "Do not contaminate water, food or feed by storage and disposal" under "Pesticide Disposal".

Please note that the name change from "Scotts Proturf 16-21-5 Starter Fertilizer" to "Andersons Starter Fertilizer With Preemergent Weed Control" is acceptable.

Submit three (3) copies of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.

crabgrass foxtail barnyardgrass

Provides special feeding to promote vigorous seedling growth and root development.

For spring and summer use

When seeding bare ground, apply just after planting grass seed in April, May or early June.

When seeding into these turfgrass areas, apply just after planting grass seed sometime between the first and fifth mowing of the year (before most dandelions are in the puffball stage). Make a follow-up treatment in 4 to 6 weeks.

After application water with a gentle spray to thoroughly moisten soil without flooding it.

Does not control dandelions, crabgrass or other weeds already established and growing at the time of application.

Precautions

Can be used on only the following varieties of bentgrass: Pennncross, Seaside, Astoria, Nemesilla, C-1, C-7 and C-19. Other varieties may be adversely affected.

Not for use on bermudagrass, zoysiagrass, or if bermudagrass seed is to be planted. Do not apply on dichondra or similar ground covers.

STORAGE AND DISPOSAL

STORAGE: Store in clean, dry place. Reseal opened bag by folding top down and securing.
