Apply any time weeds are actively growing. Do *not* apply when ground is frozen.

For bentgrass putting greens

For bentgrass putting greens apply at 0.81 lbs./1,000 sq.ft. to moist foliage for control of clover and chickweed. Repeat treatment in 3 weeks if needed.

For use on other turfgrass areas

For turfgrass areas other than greens, apply to moist or dry foliage at –

Weed	Application Rate
clover	1.61 lbs./1,000 sq.ft.
knotweed, chickweed (common and mouse-ear), sheep sorrel black medic, wild onion garlic, curly dock, ground ivy, canadian thistle; cudweed, yarrow, horseweed.	3.23 lbs./1,000 sq.ft.

For control of yarrow and wild onion and garlic start treatments in either spring or fall and repeat at a 6 month interval. May require 2 applications at the 1.61 lbs./1,000 sq.ft., 2 – 4 weeks after the first application

RESTRICTIONS

Do not apply to rootzone areas of trees and shrubs.

Do *not* apply when ground is frozen.

Delay planting grass seed until after a heavy rain or watering and not sooner than two weeks after treatment.

On new plantings delay treatment until after the second mowing.
