Your submission dated April 23, 2002

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you make the labeling changes listed below:

- 1. In the "If swallowed" statement under "First Aid" please add the word "immediately" after "doctor" so the statement reads, "Call a poison control center or doctor immediately for treatment advice...."
- 2. In the "If on skin" statement under "First Aid" please add the words "or clothing" after "skin" so the statement reads, "If on skin or clothing..."
- 3. In the "If inhaled" statement under "First Aid" please add the word "further" after "for" so the statement reads, "...Call a poison control center or doctor for further treatment advice."
- 4. For the "Metric coverage" under the "Suggested Spreader Settings" box, please change "14.86 kg" to "13.24 kg", "1022 m²" to "2044 m²" and "511 m²" so the statement reads, "Metric coverage: 13.24 kg treats 2044 m² at the RECOMMENDED RATE and 1022 m² at the DOUBLE RATE"

5. Add the following groundwater statement that applies to all triadimefon products:

"This chemical demonstrates the properties and characteristics associated with chemical detected in ground water. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in ground water contamination."

Please submit one (1) copy of your final printed labeling before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

#### **Directions for Use**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

For use on turfgrass areas consisting of Kentucky bluegrass, annual bluegrass, bentgrass, perennial ryegrass, fine fescue, bermudagrass or mixtures where these grasses predominate.

TO PREVENT DOLLAR SPOT, ANTHRACNOSE AND RUST – apply to moist or dry foliage at the RECOMMENDED RATE when environmental conditions favor disease activity. Repeat the application at two week intervals throughout the expected disease period.

TO CONTROL ACTIVE DOLLAR SPOT, ANTHRACNOSE AND RUST – apply to moist or dry foliage at two week intervals. Use the DOUBLE RATE for light to moderate infestations and the HEAVY RATE for severe disease infestations. When the disease activity is under control, apply at the RECOMMENDED RATE at two week intervals.

TO PREVENT BROWN PATCH, apply to moist or dry foliage at the DOUBLE RATE when environmental conditions favor disease activity. Repeat application at two week intervals throughout the expected disease period.

TO CONTROL ACTIVE BROWN PATCH, apply to moist or dry foliage at the HEAVY RATE every two weeks. When disease activity is under control, apply at the DOUBLE RATE at two week intervals.

To avoid product pickup, lightly irrigate treated areas soon after application.

#### Storage and Disposal

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a clean, dry place. Reseal opened bag by folding top down and securing. Protect from water and extreme heat.

PESTICIDE DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
