- Apply prior to or after sprigging 150 to 300 lbs. of product per acre (1.5 to 3.0 lbs. AI/acre) for suppression or control of listed annual grassy weeds in bermudagrass, zoysiagrass, and St. Augustinegrass.
- After application of this product on newly sprigged bermudagrass, zoysiagrass, and St. Augustinegrass, wait until the grass has filled in and the stolons have rooted down before application of other herbicide, combination fertilizer/herbicide or growth regulator products.
- On Seashore paspalum make application 10-14 days after sprigging.
- For established turf, apply at 200 to 400 lbs. of product per acre (2.0 to 4.0 lbs. AI/acre).

WHEN TO USE

Use this product to control or suppress the listed annual grassy weeds when establishing new turf areas or when treating established turf that has been thinned from winter injury, insects, diseases or other factors.
