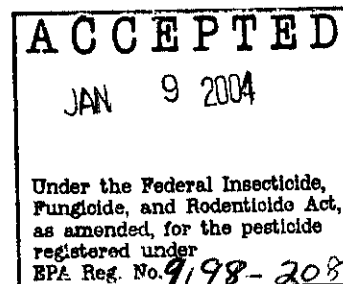

**Directions for Use**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Apply this product only as specified on this label.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

For use on turfgrass areas consisting of Kentucky bluegrass, annual bluegrass, bentgrass, perennial ryegrass, fine fescue, zoysiagrass, tall fescue, bermudagrass, St. Augustinegrass, or mixtures where these grasses predominate.

**TO PREVENT DOLLAR SPOT, ANTHRACNOSE, POWDERY MILDEW AND RUST (*Puccinia* spp.)** apply to moist or dry foliage at the **LOW RATE** when environmental conditions favor disease activity. Repeat at two week intervals throughout the expected disease period.

**TO CONTROL ACTIVE DOLLAR SPOT, ANTHRACNOSE, POWDERY MILDEW AND RUST (*Puccinia* spp.)** apply at the **MEDIUM RATE** to moist or dry foliage at two week intervals. When the disease activity is under control, apply at the **LOW RATE** at two week intervals.

**TO PREVENT BROWN PATCH** apply to moist or dry foliage at the **MEDIUM RATE** when environmental conditions favor disease activity. Repeat at two week intervals throughout the expected disease period.

**TO CONTROL ACTIVE BROWN PATCH** use a non-fertilizer fungicide such as Andersons Golf Products Systemic Fungicide to limit the amount of fertilizer applied since high levels of nitrogen applied to turf during or just prior to the onset of hot, humid weather may increase the severity of brown patch. Follow the **LOW RATE** of either product once the disease is controlled.

**TO PREVENT NECROTIC RING SPOT AND SUMMER PATCH** apply to moist or dry foliage at the **HIGH RATE**. Begin in the spring when conditions are favorable for disease development. Make 2-4 applications at monthly intervals. For best results water in after application.

**Note carefully**
