The label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended is acceptable provided you make the following changes:

Ingredient Statement:

Change the spelling of the common name "Thiophanage-methyl" to "Thiophanate-methyl".

Precautionary Statements:

Change "May be harmful if swallowed ..." to "Harmful if swallowed ..."

Personal Protective Equipment (PPE):

- Change the heading to "Personal Protective Equipment (PPE)."
- Move the Personal Protective Equipment section, including the sentences "Follow manufacturer's instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry." so that it follows the "Hazards to Humans and Domestic Animals" section.
- Change "Chemical-resistant gloves made of any waterproof gloves." to "Chemical-resistant gloves made of any waterproof material."

Directions for Use:


In the paragraph beginning "Add recommended amount to a partially filled spray tank ..." change the sentence "Apply in sufficient water to obtain through coverage." to "Apply in sufficient water to obtain thorough coverage."

Submit one (1) copy of your final printed labeling before you release the product for shipment. A stamped copy of the label is enclosed for your records.

Hazards to Humans and Domestic Animals

It is a violation of Federal Law to use this product in a manner inconsistent with it's labeling. Not for homeowner use. For use by individuals/firms licensed or registered by the state to apply ornamental or turf pest control products. Do not apply this product in a way that will contact workers or other persons either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulations.

Keep children and pets off treated areas until dry or material has washed into soil.

DO NOT APPLY THIS PRODUCT THROUGH ANY TYPE OF IRRIGATION SYSTEM.

Not for use on turf being grown for sale or other commercial use as sod.

DO NOT APPLY WITH FIXED WING OR ROTARY AIRCRAFT.

Do not apply to areas likely to be grazed by livestock and do not feed clippings to livestock or poultry.

Add recommended amount to a partially filled spray tank under agitation. Complete filling to the desired volume. Keep agitated to insure even suspension of material. Make fresh daily. Spray uniformly over the area with a boom-type or other power sprayer. Apply after mowing or avoid mowing for 12 hours after application. Apply in sufficient water to obtain through coverage, usually 5 gal. per 1000 sq. ft. of turf areas. Always treat aprons and approaches to golf greens. Under conditions of severe disease, apply at minimum retreatment intervals. Do not exceed maximum application rates and minimum retreatment intervals listed in the Maximum Use Rates table below.

FUNGO® 50 is a wettable powder for use on golf course greens, tees, lawn and fairways of Bentgrasses, Bluegrasses, Fescues, Bermudagrasses, Ryegrasses, St. Augustine grass or their mixtures to be used for the prevention and control of the below mentioned disease.

NOTE: For the following diseases, the spray should dry on the leaves, with no "water in".

Anthracnose (Colletotricum graminicola), Dollar Spot (Sclerotinia homeocarpa) – Apply at 1 oz. per 1,000 sq. ft. beginning when the disease first appears and continue at 14 day intervals as needed. As a curative, where preventative schedule is not followed, use 2 oz. per 1,000 sq. ft.

Copper Spot (Gloeocercospora sorghi), Large Brown Patch (Rhizoctonia solani), Red Thread (Corticium fuciforme), Fusarium Patch (Fusarium nivale) – Apply at 2 oz. per 1,000 sq. ft. beginning when the disease first appears and continue at 14 day intervals. Re-treat at the minimum retreatment interval under severe disease conditions.

NOTE: For the following diseases, "watering in" is required:

Fusarium Blight (*Fusarium roseum*), Necrotic Ring Spot (*Leptosphaeria korrae*), and Summer Patch (*Phialophora graminicola*) – Apply at 4-8 oz. per 1,000 sq. ft. Water into root zone by irrigating thoroughly immediately after application. Apply two applications at 14 day intervals, beginning applications when the disease first appears.

Strip Smut (*Ustilago striiformis*) – Apply at 4-8 oz. per 1,000 sq. ft. Water into root zone thoroughly immediately after application. Apply in October or early spring just before grass begins growth.
