The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the conditions listed below:

To update the "first aid" statement in accordance with PR Notice 2001-1

Conditions

- 1. The Agency accepts only one label for each registration. You must place the "Net Weight" for the other sizes on this label.
- The full "Environmental Hazards Statement" is required on sizes over 50 lbs. You may 2. place this language on the master label, specifying that it is only for the larger size containers.
- "Do not contaminate water, food, or feed by storage or disposal" should be reported 3. immediately under the "Storage and Disposal" section.
- 4. Under the "Storage and Disposal Section" change "Product Disposal" to read: "Pesticide Disposal".

FIRST AID

If swallowed: Call a poison control center immediately for treatment advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or a doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eyelids open and rinse slowly with water for 15 to 20 minutes. Remove contact lenses if present after 5 minutes then continue rinsing eye. Call poison control center or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes.

If inhaled: Move person to fresh air. If person is not breathing call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

DANGER: CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE AND SKIN BURNS. MAY BE FATAL IF ABSORBED THROUGH SKIN. MAY BE FATAL IF INHALED. DO NOT BREATHE DUST OR SPRAY MISTS. IRRITATING TO NOSE AND THROAT. HARMFUL IF SWALLOWED. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield, protective clothing and rubber gloves when handling this product. Wash thoroughly with soap and water after handling and before eating, drinking or using tobacco. Remove contaminated clothing and wash before reuse.

PHYSICAL OR CHEMICAL HAZARD - STRONG OXIDIZING AGENT. WILL BURN WITH THE EVOLUTION OF CHLORINE AND EQUALLY TOXIC GASES. CONTACT WITH WATER SLOWLY LIBERATES IRRITATING AND HAZARDOUS CHLORINE-CONTAINING GASES. DECOMPOSES AT 460°F. to 480°F. WITH LIBERATION OF HARMFUL GASES. Mix only with water. Use clean, dry utensils. Do not add this product directly into a swimming pool or spa as discoloration of the plastic liner or painted pool surface may occur. Do not place in the skimmer. Do not mix with other chemicals.

DIRECTIONS FOR USE - It is a violation of Federal law to use this product in a manner inconsistent with its labeling. WHEN ALGAE APPEARS ON BOTTOM OF POOL - Adjust the pH of the pool water to 7.2-7.6. Turn off filter and wait until water is calm enough to see spot on bottom. For best results brush the algae spots with a stiff bristle or wire brush prior to treatment. Pour ALL-CLEAR ALGAE KILL directly over the spot and allow it to settle on the bottom. Use enough ALL-CLEAR ALGAE KILL to dissolve over a period of 60 minutes, then brush algae away. WHEN POOL IS INFESTED WITH BLACK ALGAE Adjust pH and brush as explained above. Add one pound of ALL-CLEAR ALGAE KILL per 4,000 gallons of pool water and broadcast it over entire pool surface all at one time. Shut down pump for 24 hours. Follow this treatment with a thorough brushing. If a few traces of black algae remain, the above process should be repeated. Reentry into treated swimming pools/spas is prohibited above of 3 ppm of chlorine.

STORAGE AND DISPOSAL:

Store in original container, tightly closed away from heat or open flame. Store in a cool, dry, well ventilated place. Keep container off wet floors. PRODUCT DISPOSAL: Do not put spilled product, filled or partially filled containers in the trash. Dispose of waste material according to label use directions otherwise call 1-800-CLEANGER DISPOSAL: Triple rinse with water to dissolve all material container point points on the container. Place in trash or recycle. Do not contaminate water, food, or feed because of disposal container.
