To update the "first aid" statement in accordance with PR Notice 2001-1

## **Eanditions**

- 1. The Agency accepts only one label for each registration. You must place the "Net Weight" for the other sizes on this label.
- 2. The full "Environmental Hazards Statement" is required on sizes over 50 lbs. You may place this language on the master label, specifying that it is only for the larger size containers.
- 3. "Do not contaminate water, food, or feed by storage or disposal" should be reported immediately under the "Storage and Disposal" section.
- 4. Under the "Storage and Disposal Section" change "Product Disposal" to read: "Pesticide Disposal".

Mix only with water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Contamination with moisture, organic matter, or other chemicals may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible generation of fire and explosion. In case of fire, contamination or decomposition, do not reseal container. If possible isolate container in open air or well ventilated area. Flood with large volumes of water, if necessary.

Do not add this product directly into a swimming pool or spa as discoloration of the plastic liner or painted pool surface may occur. Do not piace in the skimmer. Do not mix with other chemicals.

DIRECTIONS FOR USE - It is a violation of Federal law to use this product in a manner inconsistent with its labelling. When starting up a new pool, superchlorinate to satisfy chlorine demand and to establish a chloring residual of 1.0 ppm to 1.5 ppm available chloring. To accomplish this, add 2 oz. All Clear Swimming Pool Sanitizer per 1,000 gallons of pool water. The next morning add All Clear Cyanuric Acid to stabilize the pool according to directions given on the label. All Clear Chlorinating Tablets are designed for use in Trichloro-s-triazinetrione devices. Follow the manufacturer's directions for refilling and adjusting the feed rate for the proper available chlorine level. Test pool water frequently with a suitable test kit and maintain a chlorine residual of 1.0 ppm minimum range of residual chlorine. If the residual chlorine above 1.5 ppm, adjust the cartridge to the next smaller number. An increase in weather temperature, bather lead or water temperature will cause your pool to use more chloring. You should increase the feed rate load or water temperature will cause your pool to use more chlorine. You should increase the feed rate accordingly. If the cartridge is at the maximum setting, the pump time should be increased to compensate for the increased usage. When the tablets are nearly exhausted, superchlorinate and refill when the chlorine residual of the pool reaches 1.5 ppm. Keep the pH between 7.2 and 7.6 as determined by a suitable test kit. Reently to treated swimming pools/spas is prohibited above levels of 3 ppm of chlorine.

STORAGE AND DISPOSAL: Store in original container, tightly closed away from heat or open flame. Store in a cool, dry, well ventilated place. Keep container off wet floors. PRODUCT DISPOSAL: Do not put spilled product, filled or particially filled containers in the trash. Dispose of waste material according to label use directions otherwise call 1-800-CLEANUP for guidance from your local solid waste agency. CONTAINER DISPOSAL: Triple rinse with water to dissolve all material before discarding container Do not reuse container. Place in trash or recycle. Do not contaminate water, food, or feed by storage or disposal.
