 - a. Delete the entire Phenol Coefficient claim.
 - b. Add the following misuse statement directly under the heading for use directions:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.
3. Submit five (5) copies of your final printed labeling before you release the product for shipment.



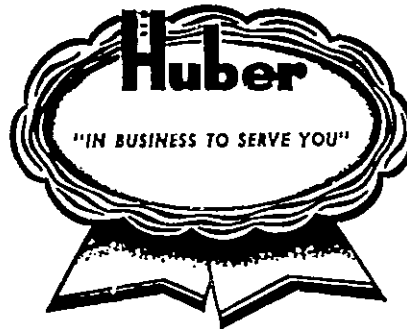
