The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10. The label submitted with the application has been stamped "Notification" and will be placed in our records. Additionally, the alternate brand name "ALLPRO PRODUCTS LAWN FOOD WITH MOSS CONTROL 12-0-4" has been added to the product record. Per your request, the two previous alternate brand names, "TRUGREEN/CHEMLAWN STEP ONE MOSS CONTROL 25-2-10" and "MASTER NURSERYMEN MOSS CONTROL WITH LAWN FERTILIZER 12-4-8" have been inactivated.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. This application will provide turf with 1/2 pound of nitrogen, 1/3 pound of iron, per 1,000 square feet, plus phosphorus and potash essential to this early spring treatment.

#### **Heavy Moss Infestations**

For heavy infestations of moss, apply at the rate of eight pounds per 1,000 square feet. A 20-pound bag covers 2,500 square feet; 40-pound bag covers 5,000 square feet, properly applied. This application will provide turf with 1 pound of nitrogen, 2/3 pounds of iron per 1,00 square feet, plus phosphorous and potash.

#### Storage and Disposal
