**DIRECTIONS:** To control most weeds and grasses for extended periods on non-cropland areas such as industrial plant sites, parking lots, loading ramps and around storage buildings and the like, apply 1-4 gallons per 1000 square feet of UL-285 after the most predominant weeds have emerged. No agitation is required. UL-285 can be applied with standard spray equipment. For treating small areas, a tank type hand sprayer or sprinkling can may be used.

**NOTE:** Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of UL-285 in their particular area or write to United.

**IMPORTANT:** Do not apply directly to or otherwise permit UL-285 to contact desirable woody or herbaceous plants or areas where their roots may extend. # WEED KILLER
