## DIRECTIONS FOR USE

The 5-10-10 fertilizer mixture with Nemagon is for the control of nematodes in cantaloupes, cucumbers, watermelons and tomatoes. The mixture should be applied ONLY when the temperature of the soil is above 50 F. Use on watermelons limited to Eastern Shore of Magyland

FOR CANTALOUPES & CUCUMBERS:

The fertilizer - Nemagon mixture should be applied in the row at the rate of 500 pounds per acre (57.4 nounds of fertilizer - Nemagon mixture to 1,000 linear feet of row) at the time of planting. Use a bean planter or similar equipment. Apply the mixture on each side of the row at a distance of 6 inches and at a depth of 6 inches.

FOR WATERMELONS: Apply as for cantaloupes and cucumbers. This will result in one-half the dosage for cantaloupes and cucumbers since the waterme'on rows are twice as far apart as the cantaloupe and cucumber rows. The rate of application for the fertilizer - Nemagon mixture on watermelons should be 250-300 pounds per acre. (The 250 pound rate is equivalent to 57.4 pounds of the fertilizer - Nemagon mixture to 1.000 linear feet of the row. The 300 pound rate is equivalent to 68.8 pounds to 1,000 linear feet of row)

FOR TOMATOES: Apply the fertilizer - Nemagon mixture at the rate of 500 pounds per acre on each side of the row and at a depth of 6 inches as soon as possible after setting. (57.4 pounds of fertilizer - Nemagon mixts + to 1,000 linear feet of row) -- (5 foot row spacing)
