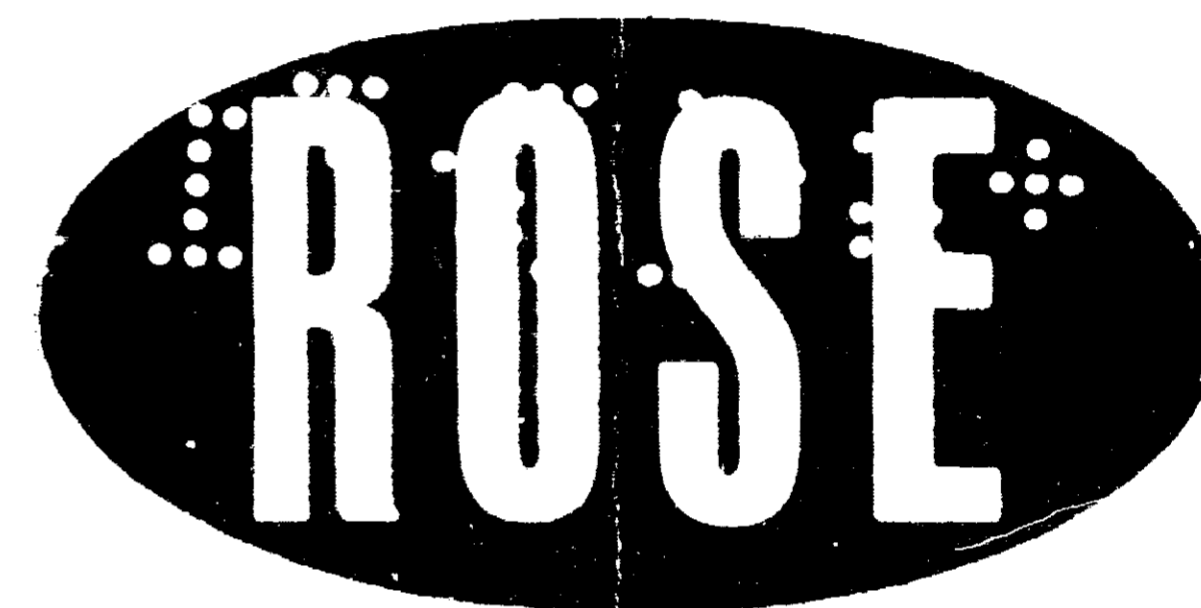

DIRECTIONS

Use product as supplied, do not dilute. Apply with standard fogging machines. Completely envelop area to be treated in accordance with the equipment manufacturer's recommendations.

FOGGING OUTDOOR AREAS — Apply at a rate of 3 quarts to 2½ gallons per acre for control of flies, gnats, adult mosquitoes and other small flying insect pests. For best control, fog thoroughly insect breeding and nesting areas, such as bushes, heavy foliage, window sills and refuse storage areas. Pay particular attention to all zones of stagnation, such as intermittently flooded areas, standing water, temporary rain pools, sloughs and log ponds. Do not fog in areas where food or feed crops are growing.
