
Precision S-488 is a concentrated product for use by experienced personnel in the control of flies, mosquitos, and cockroaches that have developed resistance to chlorinated insecticides.

DIRECTIONS FOR USE:

FOR FLIES & MOSQUITOS: The residual deposit of a mixture of 1 gallon of S-488 with 10-14 gallons of water or fuel oil will aid in control of flies and mosquitos. Thoroughly wet the surfaces where the pests breed or alight such as garbage dumps, refuse heaps, outside of barns and buildings and undergrowth near stagnant water. Repeat when necessary.

FOR REDUCTION OF ROACH POPULATION: Mix 1 gallon of S-488 with 3 gallons of fuel oil. Thoroughly wet the inside of manholes and sewage lines. Treat garbage racks and cansusually found in alleys behind buildings. Use a coarse spray and wet garbage dumps and refuse areas. Repeat when necessary.
