On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. You must make the following labeling changes:

1. The Statements of Practical Treatment or First Aid statements must be revised as follows:

**IF SWALLOWED:** Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger, or if available by administering syrup of ipecac. If person is unconscious, do not give anything by mouth and do not induce vomiting.

**IF ON SKIN:** Wash with plenty of water. Get medical attention.

**If IN EYES:** Flush eyes with plenty of water. Call a physician if irritation persists.

#### **Hazards to Human and Domestic Animals**

##### **CAUTION:**

Harmful if swallowed or absorbed through the skin. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals.

#### **Personal Protective Equipment**

The PPE must be presented as follows:

Personal Protective Equipment (PPE):

"Mixers and Handlers must wear:

- long-sleeved shirt and pants
- shoes and socks
- chemical resistant gloves

#### **User Safety Requirements**

The user safety requirements must appear on the label as follows: "Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry."

#### **User Safety Recommendations**

The user safety recommendations must be added to the label (must be placed in a box) and should read as follows:

"Users should remove PPE immediately after handling this product. wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing." Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet." Users should remove clothing immediately if pesticide

gets inside. Then wash thoroughly and put on clean clothing.

**Storage and Disposal**

The "Storage and Disposal" section should be moved to the "Directions for Use" section, directly following the statement "Violation of Federal Law" text and place in a box. As per PR Notice 83-3 and the Label Review Manual, "Container Disposal" section must be revised to read as follows:

"Container Disposal: Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke."

For purposes of clarity and consistency with other labels, the sub-header **General Information** should be placed on the label. The general information statements beginning "RANCH-O PHOS-8 prevents the...and ending and sanitation practices," be moved to the "General Information" section. Also, the sentence appearing on top of the active ingredient statements beginning "To prevent the development of horn flies...cattle" should be repeated in this section.

**General Precautions and Restrictions**

You must add the sub-heading "General Precautions and Restrictions" to the label and include the following information:

"Do not apply this product in a way that will contact workers or other persons, either directly or through drift."

"Only protected handlers may be in the area during application." Since horses are not listed as a site on this label, the following statement must be removed:

"This product is not be used on horses destined for slaughter."


**Directions for Use (Application Instructions)**

The subheading "Application Instructions" should be added to the label directly below the General Information section and the following information should be placed there:

Feed RANCH-O PHOS-8...restricts fly activity."

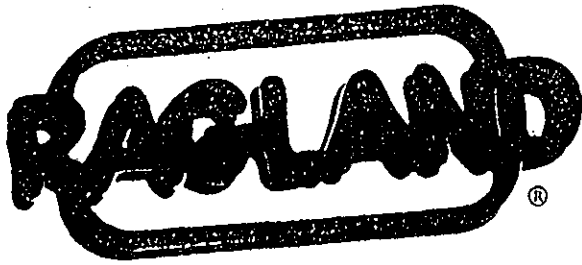

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS

### CAUTION

Harmful if swallowed. Avoid contact with skin and eyes. Avoid breathing dust. Wash thoroughly with soap and water after handling and before eating or smoking. Wear long sleeved shirt and pants; chemical resistant gloves, shoes and socks for protection when handling. This product may cause skin sensitization reactions in certain individuals.

### STATEMENT OF PRACTICAL TREATMENT

- If Swallowed** — Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit liquid is clear. Call a physician immediately. Do not induce vomiting or give anything by mouth to an unconscious person.
- If Inhaled** — Remove victim to fresh air. Apply respiration if necessary.
- If on Skin** — Remove contaminated clothing and wash affected areas with soap and water.
- If In Eyes** — Flush eyes with plenty of water. Call a physician if irritation persists.

### ENVIRONMENTAL HAZARDS

This pesticide is highly toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or public waters unless this product is specifically identified and addressed in a National Pollution Discharge Elimination System (NPDES) permit. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. For guidance contact your State Water Board or the Regional Office of EPA.

### DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Feed RANCH-O PHOS-8 at the rate of 3 ounces per 1000 pounds of body weight head per day free choice or by mixing it into the ground grain or complete daily ration. RANCH-O PHOS-8 may be fed up to slaughter and to lactating dairy cows. Start feeding RANCH-O PHOS-8 early in the spring before flies begin to appear and continue feeding throughout the summer into the fall until cold weather restricts fly activity.

RANCH-O PHOS-8 prevents the development of horn flies, face flies, house flies, and stable flies in the manure of treated cattle but is not effective against existing adult flies. When starting a feeding program during the fly season, it is desirable to use other control measures to reduce the population of existing adult flies.

In some cases, supplemental fly control measures may be needed in and around cattle lots and buildings to control adult house flies and stable flies which can breed not only in cattle manure but in other decaying vegetable matter or silage on the premises.

In order to achieve optimum fly control, RANCH-O PHOS-8 should be used in conjunction with other good management and sanitation practices.

This product is not to be used on horses destined for slaughter.

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Storage** — Store in a dry place in original container.

**Container Disposal** — Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into mixing equipment. Then dispose of liner to a sanitary landfill or by incineration, if allowed by State and local authorities. If drum is contaminate and cannot be reused, dispose of in the same manner.

**Pesticide Disposal** — Pesticide that cannot be used or chemically reprocessed should be disposed of at an approved waste disposal facility.
