It is a violation of federal law to use this product in a manner inconsistent with its labeling.

INDUSTRIAL AND COMMERCIAL RECIRCULATING COOLING TOWERS: FOR CONTROL OF ALGAE AND SLIME-FORMING BACTERIA:

Dosages for recirculating cooling tower water systems will depend on the conditions of the system before treatment initiation. Clean heavily contaminated systems prior to treatment. Apply AMA[®]-3523 to the cleaned system or when growth is first noticed according to the following schedule:

INITIAL DOSAGE: Apply 19.4 to 32.4 fluid ounces (150 ppm to 205 ppm) of AMA[®]-3523 per each 1,000 gallons of water in the system. This dose may be applied once, twice or three times weekly or as needed to maintain control.

SUBSEQUENT DOSAGE: When microbial control is evident, add 5.2 to 15.6 fluid ounces (40 to 120 ppm) of AMA[®]-3523 per 1,000 gallons of water in the system daily or every 3 days or as needed to maintain control.

NOTE: AMA[®]-3523 must be added at a point in the cooling system where uniform mixing and even distribution will occur, such as the cooling tower basin or sump.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS
