### PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

**CAUTION:** Harmful if swallowed or inhaled. Avoid breathing dust. May cause irritation of nose, throat, eyes and skin. Avoid contact with skin. Wash thoroughly after handling and before eating or smoking. Avoid contamination of food and foodstuffs. Do not use on household pets or humans.

### STATEMENTS OF PRACTICAL TREATMENT

**IF SWALLOWED:** Call a physician or Poison Control Center immediately. Induce vomiting by giving victim 1 or 2 glasses of water and touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. **IF INHALED:** Remove victim to fresh air. Apply artificial respiration if indicated. **IF IN EYES:** Flush eyes with plenty of water. Get medical attention if irritation persists. **IF ON SKIN:** Remove contaminated clothing. Wash affected area with soap and water.

### ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning equipment or disposal of wastes. Apply this product only as specified on this label. This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Store product in original container in a cool, dry, locked, place out of reach of children. Do not reuse empty container. Wrap and put in trash.

### USE INFORMATION:

A modern formulation containing insecticide and fungicide designed to control powdery mildew on roses, azaleas, zinnias, sweetpeas and hydrangeas; black spot on roses, red spider mites on plants such as roses, azaleas, camellias and gardenias; Sevin® in the formulation controls: Rose chiggers, Rose slugs, Japanese Beetles, Leaf Rollers, Leafhoppers, Rose Aphids, exposed thrips and blister beetles on roses.

**HOW TO USE:** The dust is contained in a ready to use squeeze applicator. Lift hinged cap and squeeze container. Apply dust from below the leaves to insure that both lower and upper surfaces are covered with a thin film of dust. The duster should be held 8 to 10 inches from the part of the plant receiving the dust. To refill container remove bottom closure.

**WHEN TO USE:** Start a regular preventative program as soon as new growth appears. Under normal conditions, apply every 7 to 14 days during growing season. Treat at least weekly during periods of severe infection caused by periods of wet weather. Apply dust in early morning or late evening when moisture is present on plants, temperature is low and air still. Do not treat during excessively high temperatures (above 85° F.) as sulfur may burn foliage. Additional applications are recommended immediately after every rain.

Do not use within 10 days of an oil spray. Subsequent planting of food and feed crops in treated areas must be made with crops on this or other carbonyl labels.
